Terms and Conditions

Maximum capacity: Seabirds 1 sleeps 5, Seabirds 4 sleeps 4, (1 and 4 both include a parking space if required). Seabirds 2,3 and 5 and Barnoon all sleep 2.

Make a provisional reservation by phone or email. £50 deposit per week booked (+£5 garage deposit p/w if appropriate) and this form secures your reservation. **The balance is due no later than one calendar month before your holiday start date.** Please make a note in your diary. A separate damage deposit cheque must be sent with the balance (£100 flats 1 and 4; other flats £50) - this will be destroyed when you return the keys, presuming that you have not caused any additional expense. We do not deduct the cost of the odd broken glass or mug from this deposit, but we would prefer you to tell us so that we can replace any breakages.

All flats are strictly **no smoking**, and **no pets** unless by special arrangement. You have access to your flat from 3pm on the start day, and **must vacate the flat by 10am on the final day**, leaving it in a reasonable state. Please don't leave your washing up for our cleaners!

As soon as possible, **post the keys back to me.**

Every effort is made to ensure that everything provided is good working order, but no guarantee can be given or liability accepted for any breakdown. Notify us at once of any problem and we will rectify it as quickly as possible. If a flat was somehow made uninhabitable and we were unable to honour your booking, all payments made would be refunded but no other compensation could be given.

If you have to cancel your holiday, we will make every effort to re-let, and if we can do so we will refund your payments, less 10%
